Attached please find a list of cases that have been remotely set for Status hearings on January 10, 2022 at 3:30 p.m.

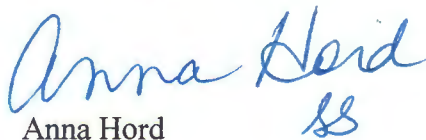
All Motions for Continuance must be in writing and E-filed at least 3 days prior to the docket date.
